Director of music report September 2022

Our debut at state level contesting was, I believe a strong success for our band. The journey towards our goal helped our band grow as musicians, and as a group which was evidenced throughout the proceedings of the day and the rehearsal following>

Two things that need to be considered following the contest: 1 We borrowed an EEb Tuba from southern brass, we now need to either return it (and if that is the case I believe we should offer them some monetary consideration for their generosity) discuss the possibility of purchasing it from them or a suitable on going hire fee to retain it at our band.

Secondly, it was evident at the contest that most other bands had a large percussion section which enabled them to provide a variety of additional instruments and sounds throughout their performances. I believe we should be looking down the same path, however we have a couple of issues to resolve, the first is where do we find additional percussionists? Capable of playing mallets etc or even high-quality kit players to free Jarrad up to other instruments and the second is where do these instruments come from? Jarrad already takes a car load of gear and nearly an hour to set up and knock it down it is unfeasible to expect him to do more, plus it's not right to expect him to supply instruments for others to play on. As musical director, I am asking to committee to consider and find a solution for this conundrum.

Looking ahead we must solidify our attendance at Gulgong, this means we need to ensure we have a confirmed band going so I can select suitable repertoire for the occasion. We need a program of events so members can make suitable plans and get it up and running now we are clear of contesting.
