Director of Music Report

November 2023 committee meeting

October was a relatively quiet month with there being no public performances of the band, however my company in partnership with Reeds and More ran a successful holiday workshop which has provided us with a good model to use should the community band wish to run a similar workshop early next year.

I harbour a concern regarding the lack of a trombone section. This has come about due to illness and injury of the section; however we must continue to try and recruit some new players in that area. A few more members to the Kids band and the dance band would not go amiss either.

November has three performances scheduled: Remembrance Day in Camden, followed by a Remembrance Day concert in Bundanoon the following day, both events have had considerable work applied to them to ensure a good performance. Later in the Month the band will play in Camden as part of the Councils Cultural Fusion program.

Looking into next year, I have booked the Civic Centre for a concert, this should be a celebration of the 30 years our band in Camden, the music will basically flow this way: Segment 1; a garage band signifying the early start of the band. Segment 2; forming as a big band playing some of the early music. Segment 3; A true community band as we emerge as the Camden Community Band and finally the contest band of today. It will also include the kids' band etc. I have also started to prepare some students to video and operate the audio visual etc. What the band needs to focus on will be: Ticketing, advertising, raffles, decorating the room with suitable memorabilia and a title for the concert. I believe we should be encouraging other non-committee members to work on these roles under the guidance of the committee.

The Band Assoc president's reply to my letter regarding contesting has been displayed during rehearsals for several weeks, as yet I am unaware of any action being taken to regrade bands or address the concerns expressed. I will reserve my decision regarding future contests at this time.
