Welcome back to a new year of music making. It is my wish to make this year a fun, light-hearted year with lots of opportunities and challenges for all.

December saw us rained out at the St James Carols unfortunately, but we have been again booked for Dec 14 this year and hopefully a better weather. Also, in December we joined our Wollondilly colleagues at the performing arts centre to perform a Christmas concert which was very well received by the audience, we are now looking at a repeat performance this year in the Civic Centre in Camden.

Australia Day had our parade band out in record numbers, the band sounded great and looked good as we marched up the street. There is a video available and photos available on the website.
